● Look for the new TI retiree health plan identification card in your mailbox before January if you are enrolled in the Blue Cross Blue Shield PPO or an HMO.

Effective in 2005, each BCBS subscriber's ID card and explanations of Benefits (EOBs) will have a unique identification number instead of the person's Social Security number.

Then, contact the insurance carrier through TI SmartLink to request an ID card.

Templeton speaks to TI retirees at Big Event

TI President and CEO Rich Templeton was upbeat about the company's future Nov. 10 at the annual Big Event saluting TI retirees.

Rich spoke on the state of TI to approximately 1,000 retirees, spouses, TI volunteers and exhibitors at Market Hall in Dallas.

"The financial numbers pretty much tell the story," Rich said, citing a strong rebound over the past two years following the market's last downturn.

TI gains market share

"TI's revenue has been growing faster than our semiconductor competitors. That's good news, because in a brutally competitive marketplace, TI has been gaining market share."

In the third quarter, revenue was \$3.25 billion. That was up 28 percent from the same period in 2003, but was essentially flat compared to the second quarter.

Excellent third quarter results in wireless and digital light processing (DLP) were offset by some weakness in some analog product lines, Rich said. TI sales declined at some companies that distribute TI analog products, as

TIAA golf tourney raises \$23,000

Jerry Pierce is TI Alumni Association vice president for Ongoing Education — a job where he has contributed generously of his time and talent since TIAA began five years ago.

The Ongoing Education Committee goal is to provide interesting and timely information that is important to TI retirees. The committee is responsible for developing and holding three or four seminars each year. Jerry plays a major role in contacting speakers, arranging for facilities and conducting the events.

TIAA members who work together with Jerry on the Ongoing Education committee are Hector Cardenas, Mary Ann Eschrich, John Jurusich, Roy Long, Loyd Morris Jr., Jim Peterman, Jim Polozeck and Bill Stearns.

"When we first formed in September 1999, we asked what people wanted to know about and they told us," Jerry said in a TI Alumni Connected article. Attendance grew quickly, he said, "because we are giving the people exactly what they told us they wanted."

Responding to popular demand, the TIAA Ongoing Education committee has sponsored seminars on:

Financial topics such as mutual funds, bonds, stocks, 401(k) plan and pension rollovers, and annuities;

Estate and trust planning, probate issues and elder law;

Medicare, Social Security issues and long-term care insurance;

TI health benefits issues; and Health and wellness.

"These seminars have been well received, with several hundred retirees attending," Jerry said. "Some attracted as many as many as 700 people."

In fact, a significant challenge Jerry faces is getting meeting rooms large enough to seat the number of retirees who want to

participate.

The first Ongoing Education seminar, which focused on financial planning, was held March 28, 2000, in the auditorium at the Texans Credit Union Center in Richardson. On June 29, a sold-out crowd overflowed the room for a health insurance and Social Security seminar.

To accommodate the burgeoning audience, the next seminar was moved to the larger Plano Centre at 2000 E. Spring Creek Parkway in Plano. Now, Jerry regularly books Plano Centre for the annual seminars dealing with health benefits enrollment and program changes.

Jerry, a Tyler, Texas, native, completed three degrees at Southern Methodist University — a BS in Mathematics, BBS in Business

and an MBA in Business.

He joined TI in 1962 and was always employed in the financial area. He served as a division controller, as vice president, Corporate Operations Controller and as vice president, Director of Audit Services.

Jerry is a certified financial planner (CFP) and, since his TI retirement, has been employed as an Investment Representative with Edward Jones — a full-service financial services firm that has been around since 1871.

Jones has more than 8,000 offices in the United States, and most have only two people in them — the Investment Representative and the Branch Office Administrator (BOA).

The BOA working with Jerry is Connie Gibbs, whom many

TIAA members have met at the registration desk at Ongoing Education seminars. Although Connie is not a former TIER, she spends countless hours of her own time working on projects for TIAA. Jerry said, "Connie is the one who always greets you with a smile at the seminars."

Jerry said the reason he went to work for Jones after retiring from TI was the commitment to service that Jones has for its clients. This is a service he had experienced first hand, since he was an Edward Jones client for many years before retiring from TI.

In addition to his work and TIAA, Jerry is very active in his church. He has two sons and six grandchildren in the Dallas area.

these customers worked to burn off the excess.

"That was still going on as we started the current quarter. So we expect fourth-quarter revenue will decline somewhat from the third quarter. While we think this flat patch is related to inventory, nobody really knows if this is just temporary or if we're starting another cycle," he said.

Rich said we are in a market place where communications and entertainment are driving semiconductor technology. These areas rely on TI's core expertise in real-time signal processing.

"Today, there are 1.6 billion users of cell phones around the world," he said. "Half of all cell phones shipped worldwide use a TI digital signal processor. Feature-loaded cell phones demand the more capable DSPs that TI is

currently producing."

Retiree Efforts Praised

Rich congratulated TI Alumni Association members for keeping retirees linked to the company and to each other and for their volunteer efforts that benefit the community.

He recognized the team of retirees who are helping with the book on TI history that will be published next year to mark TI's 75th anniversary.

Additionally, he thanked Dallas-area retirees in the TI Health Benefits Interest Group (TI HBIG) for their work ahead of the 2005 health benefits enrollment period.

And he generally praised the retirees' contributions during their careers that have contributed to the current success of TI and the quality of life in our community.

Sharing Healthcare Costs

Rich emphasized that healthcare costs are an important issue to him, the company and the board of directors.

After much consultation with retirees and lots of work by the Health Benefits organization, TI's board of directors this year approved a one-time contribution of more than \$80 million to enhance the trust fund TI uses to pay medical benefits.

"TI still must share healthcare costs with retirees and active employees, but this one-time contribution should slow down the rate that your personal costs increase," Rich said. "Many companies have dropped health benefits for retirees. We did not want to do that, and we did not do that."

Day Packed With Activities

The Big Event gave retirees an opportunity to socialize with for-

mer coworkers, visit exhibits, get pneumonia shots and/or stroke or lipid screening, attend various seminars and enjoy a buffet lunch featuring barbecue brisket.

Attendees could watch a continuous slide presentation on a big screen above the stage. It showed photos of TIAA activities and contributors to The Senior Source in the name of TIAA. John Byers, TIAA membership vice president and webmaster of the TIAA Web site (www.tialumni.org) produced the slide show.

TIAA President Ed Hassler thanked TI for underwriting the Big Event and other TIAA events and expressed his appreciation to the 65 Big Event volunteers — retirees and active TIers — attired in golden yellow T-shirts for the autumn celebration.

Jerry Brandenburg, TIAA Activities vice president and former TIAA president, thanked Ed

for heading the Big Event committee.

Event-goers who filled out the event survey form had a chance to win one of 10 gift certificates at drawings during the program. The Dallas Tap Dazzlers, an exciting ensemble of jazz-tap dancers with a minimum age of 45, provided entertainment between the drawings.

Russ Hicks was top bidder at a silent auction for a 300-mm (12-inch) silicon wafer autographed by Jack Kilby. Jack, inventor of the integrated circuit, was awarded the Nobel Prize in the year 2000. The "slice" was produced in DMOS 6. Proceeds from the silent auction will go to The Senior Source.

Next year's Big Event is already booked for Nov. 9, 2005, at Market Hall.
